  - Shots fired on 8/7/16 no one was found to be shot, but three shell casings were found and a bullet ricocheted and broke a nearby glass door

**Request for Approval of Proposed Event at Caldwell Park** for Halloween event on Saturday, October 29, 1:30-4. June Reaves represented the Lutheran Church. Approved with all in favor and none opposed.

**Preliminary Discussion of Proposed Community Garden in Rushton Park** in the old volleyball court area. (See attached) Possible joint effort of IPC, Laney DeJonge of Rojo, and maybe the newly formed neighborhood garden club. Michelle Reynolds was present to explain some details and share her experience and success with implementing community gardens. Estimated costs to be \$5k-\$15k.

    - Funding for Kingston Fire Station is tabled again awaiting more details
