\$41,157 (+ \$5,000 once city budget is approved)

Alabama Environmental Council request for donation from NA:

Laney DeJonge of the AEC spoke about their 50th anniversary. 30 years ago they started the recycling center downtown and in 2016 they moved to Avondale at 4330 1st Ave. South. Visit www.AEConline.org and check out the "RecycAL" tab for details on what to recycle there – all curbside recyclables plus cork, cigarette butts, TVs, water filters, lightbulbs glass for a small fee, and more! They are working to get the city to use glass as landscaping mulch, etc. AEC started curbside recycling in 1997 with a 60% participation rate. The city took over and it has dropped to 3% participation. The AC started a business recycling program that is approximately \$100/month where they pick up glass recycling from local businesses.

They have an annual budget of \$350,000, and in 2016 they cut staff and recycling center hours and had a reduced budget of \$200,000. They're asking for \$50,000 from the city. City used to give \$20,000/yr for

recycling center and the AEC recycles almost 2 times as much as the city. They also pick up from schools for free.

Curbside recycling (picked up in city trucks from residences but not apartment buildings – taken to Birmingham Recycling and Recovery) on Wednesdays accepts the following (in paper bags, cardboard boxes, or plastic bins):

Aluminum, tin, steel, plastics #1 and #2, paper, cardboard (not waxed or soiled).

Motion to donate \$1,000, motion seconded – all in favor, none opposed Motion to donate \$1,000 from discretionary funds (once budget is approved) made by Martha Oyster, motion seconded – all in favor, none opposed

St. Vincent's Hospital re: issues on 28th St.

Brenna Powell and Andrew Cain addressed illegal parking issues along 28th St. S. and impacts of new curb cuts and parking deck expansion (to add 200 parking spots), erosion and vegetation buffer not being maintained along 28th to 10th Ct., and house owned by hospital on 28th not being maintained and squatters recently reported to police.

Newest curb cut on 28th is physician only entrance/exit. Master plan for hospital was approved in 2010. Plan to alleviate traffic flow onto Clairmont/University includes removing 5 parking spots along east side of 28th St. and making center lane a left turn lane and far right lane a right/straight/left turn lane. Resident suggested security officer stationed along 28th St. to help direct traffic and help prevent illegal parking. From 8am-11am there has been a hospital officer stationed in that area (for the past week). Reisdent suggested disciplinary action for St. Vincent's Associates/employees that park illegally on 28th. St. Vincent's thinks it is people who work in the POBs (Professional Office Buildings) on SVH campus who are parking illegally.

St.VH Security dispatch: 205-939-7799. Call them when you see illegal parking in the area and suspect it is hospital employees.

Community Resource Officer Gregory Jones is no longer working for the city. Our new CRO is Joi Coke.

Sister Houses (on Rhodes Park): Bruce Lanier, Head of the Design Review Committee spoke about recent developments...Committee met with owner and approved plan for installing new gutters, roofs, and eaves and removing scaffolding and then (within 3 months) present a shell package (plan to address exteriors). The houses have been condemned since 2005, special repair permits have been issued but little/no progress. City Council must approve Special Repair Permits, and technically if no work is done then houses are demolished. (Somehow these houses have avoided demolition). Resident suggested having a neighborhood rep. to oversee the process. (No one volunteered.)
